Parking

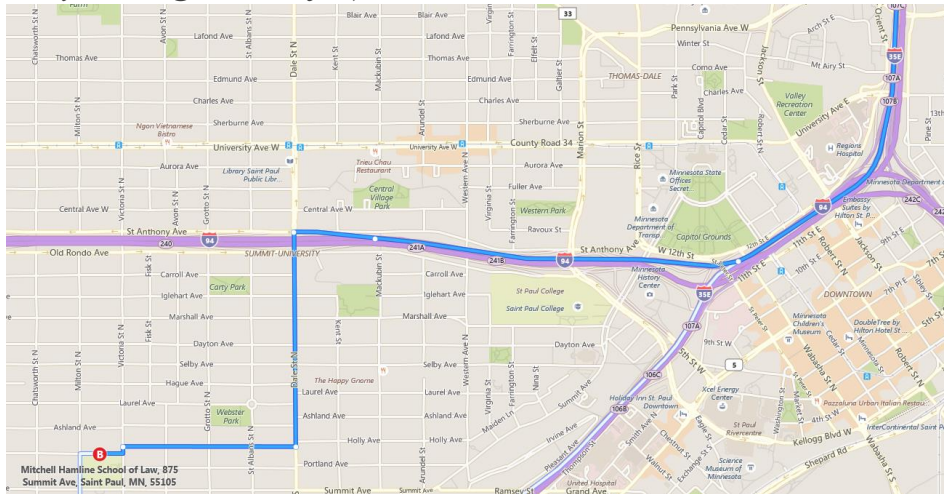
Limited parking is available in the Summit Church parking lot on Victoria just north of Summit, and in Mitchell Hamline's overflow parking lot at Grotto and Summit, about 2 blocks east of the law school on Summit Avenue. There are also a handful of visitor spots in Mitchell Hamline's main parking lot on the corner of Victoria and Summit along the Summit (South) side, as well as street parking. Do not park in spaces not marked for visitors as those are permit-only.

875 Summit Avenue / St. Paul, MN 55105

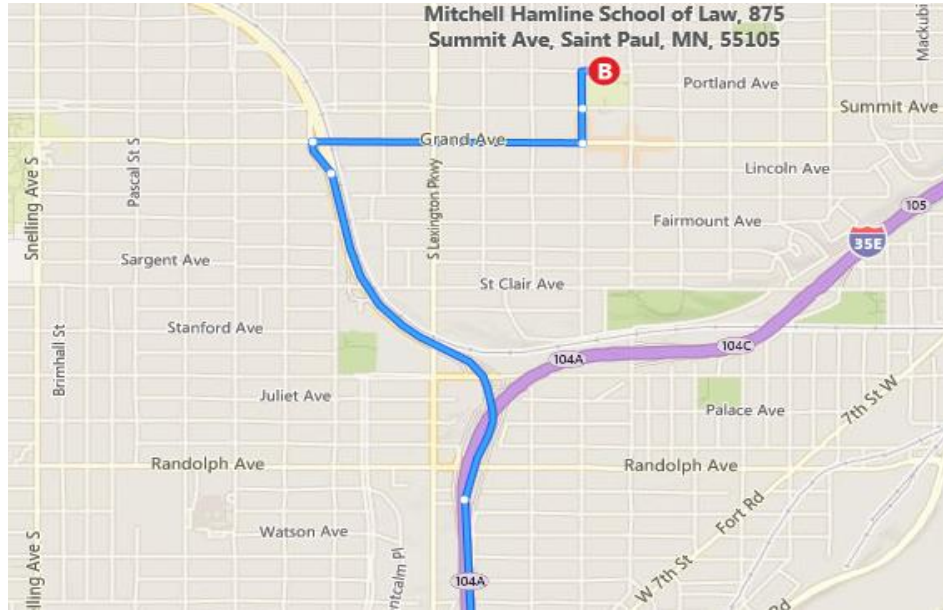
From the North:

Follow 35E south to 94 west, taking exit 240 for **Dale Street**. Turn left onto **Dale Street**, go 0.6 miles and turn **RIGHT** onto **Holly Ave**. In 0.5 miles, turn left on **Victoria Street**, and immediately right onto **Portland Avenue**. Arrive at 875 Summit Avenue on the left. *(if you reach Milton Street, you've gone too far).*



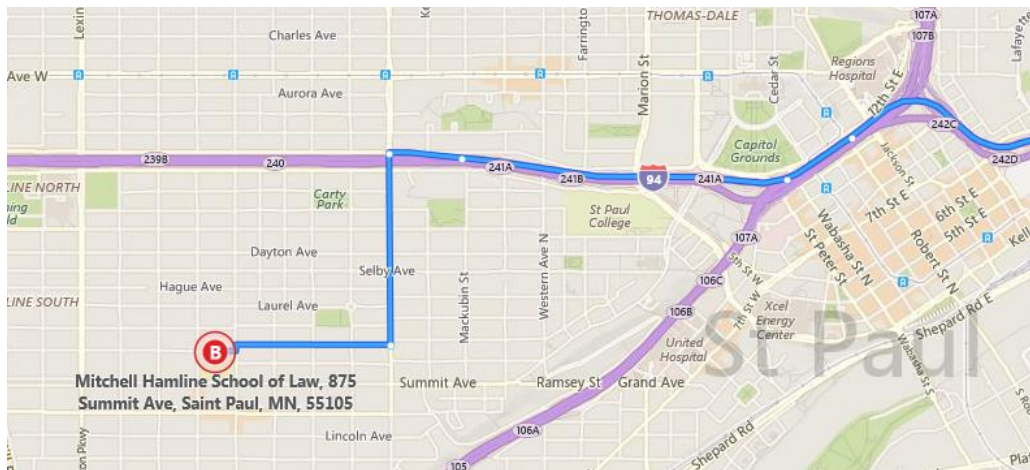
From the South:

Follow 35E north to exit 104B, Ayd Mill Road. Keeping left, continue on Ayd Mill Road for 1.1 miles and turn right onto **Grand Avenue**. In 0.7 miles, turn left onto **Milton Street South**. In 0.1 miles, turn right onto **Portland Avenue**. Arrive at 875 Summit Avenue on the right. (*if you reach Victoria Street, you've gone too far*).



From the East:

Follow 94 West to exit 240 for **Dale Street**. Turn left onto **Dale Street**, go 0.6 miles and turn **RIGHT** onto **Holly Ave**. In 0.5 miles, turn left on **Victoria Street**, and immediately right onto **Portland Avenue**. Arrive at 875 Summit Avenue on the left. (*if you reach Milton Street, you've gone too far*).



From the West:

Follow 394 east towards Minneapolis to exit 88, following signs for **94 East**. After 7.9 miles, at exit 239B, take ramp right for Concordia Avenue toward **Lexington Parkway**. Turn right on **Lexington Parkway**, travel 0.4 miles, and turn left onto **Laurel Avenue**. In 0.3 miles, turn right onto **Chatsworth Street North**, and take the next left onto **Portland Avenue**. Arrive at 875 Summit Avenue on the right. *(if you reach Victoria Street, you've gone too far).*
