# **ABOUT THE CONFERENCE**

**MnATSA** is dedicated to the promotion of education, research, and professional intervention on sexual abuse issues. The Minnesota chapter is organized to acknowledge and promote the national and international programs of the Association for the Treatment of Sexual Abusers. The 24<sup>th</sup> Annual MnATSA conference will address treatment, assessment, and supervision issues that arise in working with adolescents and adults who have sexually abused. This conference is for psychologists, social workers, corrections agents, mental health providers, judges, attorneys, sex crimes investigators, polygraph examiners, dispositional advisors, victim advocates, correctional staff, and others who work in these or related fields.

## **PROGRAM HIGHLIGHTS**

### **Keynote Address and Workshops by Nationally Recognized Experts**

**Emily Baxter, JD**, is the Executive Director of We Are All Criminals. Prior to this position, Emily served as the Director of Public Policy at the Council on Crime and Justice and as an assistant public defender at the Regional Native Public Defense Corporation.

**Luke Malone, MA**, is a journalist and has written articles and produced podcasts and television shows about sexual abuse. He is currently working on a book with Dr. Elizabeth Letourneau which focuses on child sexual abuse as a preventable public health issue.

**James Wadley, PhD**, is a Professor and Chair of the Counseling and Master of Human Services department at Lincoln University, Pennsylvania. He is the founding editor of the Journal of Black Sexuality and Relationships.

**Jon Brandt, MSW**, is the Founder and Director of Mapletree, a residential program for adolescent offenders. Since 1983, Jon has been providing assessments and treatment to adolescents who have sexually offended, repairing relationships with victims, and restoring families.

**David Delmonico, PhD**, is a Professor at Duquesne University in Pittsburgh, PA. He conducts research, consultation, and training on topics such as cybersex and cyber offense.

**Karina Forrest-Perkins, MHR**, is a national speaker and consultant on systems improvement, social determinants of health, developmental trauma, and integrated health strategies.

**Brian Heinsohn, MA**, is a Corrections Program Director at the Minnesota Department of Corrections (DOC) where he supervises the Risk Assessment/Community Notification unit psychologists and provides trainings on dynamic risk assessment. He is a Certified Dynamic Supervision Protocol (DSP) Trainer, which includes the Static-99R, Stable-2007, and Acute-2007 actuarial instruments.

**Eric Imhof, PsyD**, established Specialized Treatment and Assessment Resources in Florida. In 2013, after having undergone extensive training in the assessment of ASD, including the ADOS-2, Dr. Imhof began working on specialized cases including comorbid cases of Autism Spectrum Disorder and Paraphilias.

**Stephen Kuniak, PhD**, is an Assistant Professor in the Graduate Counseling Program at Messiah University in Pennsylvania. His research and clinical practice focus on the exploration of “gamers” as a culture.

**Charles Samenaw, MD**, is an Associate Professor of Psychiatry and Behavioral Sciences at the Medical Faculty Associates, George Washington School of Medicine. He sees patients both in the outpatient and hospital setting, as well as teaches in the medical school. His research focuses on physicians with professionalism and conduct problems.

**Kim Spence, PhD**, has been the Coordinator of Educational and Training Programs for the Center for Autism and Related Disabilities (CARD) at the University of Central Florida since 1999. Since 2017 she has been the Clinical Director of Autism Support Services for Specialized Treatment & Assessment Resources.

**Angeline Stanislaus, MD**, is the Chief Medical Officer for the Missouri Department of Mental Health where she is highly involved in program development at Missouri’s Sexually Violent Predator program. She teaches topics related to sex offender evaluations to forensic psychiatry fellows at St. Louis University and the University of Missouri- Columbia.

**The MnATSA Keynote Addresses** will be live but the majority of the workshops will be pre-recorded. 1. **How to Score, Interpret, and Report Static-99R Scores** (This is available only to those who attend the live workshop. It will not be recorded)

*Brian Heinsohn, MA, Minnesota Department of Corrections, St. Paul, MN*

The Static-99R is an actuarial risk assessment measure that predicts sexual and violent recidivism for adult male sex offenders. It can be scored based on demographic information and a detailed criminal history and does not involve an interview. This training is appropriate for anyone interested in assessing sex offender recidivism risk. Background, scoring, and interpretation of Static-99R scores will be covered.

2. **Adolescent Sexual Misconduct: Pathways to Offending and Effective Interventions**

*Jon Brandt, MSW, Mapletree, Maplewood, MN*

Sexual misconduct is socially and culturally defined, and the criminalizing of sex is constantly evolving, so there are many pathways to sexual abuse. Teenagers cannot intuitively know society's rules for interpersonal sex. When offending occurs, the most recent, credible research indicates that sexual recidivism for juveniles is less than 3%, regardless of interventions. But laws intended for adults migrated into the juvenile system, resulting in over-pathologizing teenagers, overreaching interventions, and life-changing consequences. By focusing interventions on the low likelihood of reoffending, we overlook the need to repair the collateral damage of sexual abuse. With a review of research and literature, including ATSA's Adolescent Practice Guidelines (2017), there will be a discussion about the essential elements of effective interventions, how the treatment of sexual misconduct has been conflated with management, and how professionals can ensure both public safety and successful outcomes for offenders, victims, and their families. There will be many suggestions for both best practices and systemic reforms.

3. **Autism and Sexual Offending: Is it Autism, Deviance, or Both?**

*Eric Imhof, PsyD, Specialized Treatment & Assessment Resources, PA, Cocoa, Florida*

Beginning with an overview of autism spectrum disorders (ASD), the presenters will elucidate clinical differences in clients with ASD who engage in inappropriate sexual behavior versus clients with ASD and a comorbid paraphilic disorder(s). A particular emphasis will be placed on the diagnosis of Pedophilic Disorder; and targeted suggestions will be offered to best educate the court regarding this diagnosis and misperceptions related to risk and dangerousness. Recommendations for comprehensive forensic assessments of individuals with ASD, including differential diagnosis, risk assessment, and the identification of individual client needs will be discussed, utilizing case examples.

## 4. Developmental and Complex Trauma: The Impact of Stress Accumulation and How We Can Be Truly Effective Serving Patients, Clients, and Colleagues

This workshop will provide a basic overview behind the science of brain development; the accumulation of stress during the life-course, the difference between situational and complex trauma; and the normal adaptive response humans have to overwhelming stress in their environment. Additionally, participants will understand the prevalence of stress accumulation in the human population and how this stress manifests in behavior, decisions, and systems. Tools and guidance will be provided re: those serving individuals living with high stress histories, self-management for the caregiver, and how we might course correct systems organically affected.

## Leading Conversations about the Convergence of Sexuality and Race while Working with Minor Attracted Individuals

*James Wadley, PhD, Lincoln University, Lincoln University, PA*

Mental health clinicians, therapists, healers, advocates, and researchers sometimes struggle with engaging minor attracted adult clients around sexual health and racial issues. What makes discussions about sexuality and race challenging with this special population is that practitioners have not been adequately trained to engage in this sensitive discussion and be skillful at providing appropriate therapeutic interventions. Sometimes the racial identities between the therapist and client are different and seemingly creates challenges for therapeutic access, engagement, maintenance, and discharge. As an undercurrent, therapists may not have a solid grasp of how the concepts of power, privilege, systemic oppression, white supremacy, and colorism impact therapeutic delivery with those whose orientation/identity is towards minors. This conversation is an invitation for practitioners to reflect and lead conversations about the convergence of sexuality and race and the resulting impact of effective therapeutic delivery with clients.

Journalist Luke Malone conducts a live interview with Adam, the subject of his award-winning print and radio series, about a young, self-identified pedophile who formed a self-help group in order to help cope with his recently discovered—and wholly unwanted—attraction to children. Luke and Adam will discuss Adam's evolving understanding of his attraction, what life has been like for Adam in the intervening years, including how his sexuality has evolved, and what therapeutic options are available today for young people who struggle with pedophilic interest.

### **7. Raw to Reel: Drugs, Race, and Sex in Trenton, NJ**

*James Wadley, PhD, Lincoln University, Lincoln University, PA*

Discussions about the confluence of drugs (addiction), race, and sex are seemingly elusive for mental health practitioners and their constituents. What makes these discussions about sexuality challenging is that culture (e.g., music, art, fashion, media, education, language, etc.), society, and respective communities may offer conflicting information. These inconsistent messages may make it difficult for professionals to have a strong conception about how to therapeutically engage in restorative practices with clients who have experienced personal or relational trauma from unmet expectations. This workshop uses the documentary, *Raw to Reel: Drugs, Race, and Sex in Trenton, New Jersey* as a medium to invite practitioners to consider and share how they might engage clients and constituents in complex conversations about oppressed identities, relational initiation and negotiation, trauma, addiction, race, and sex.

### **8. Sexting: Flirting or Felony**

Youth created sexual images creates new challenges for parents, mental health providers, youth workers, and those working with adults who may be requesting these images. This presentation provides tools to help professionals get on the front end of the problem of youth sending and receiving sexual materials before they are faced head on with challenging mental health or criminal scenarios.

### **9. Optimizing Management of Hypersexuality and Sexual Preoccupation by the Combined Use of Medications and Behavioral Techniques**

Sexual preoccupation and hypersexual behaviors are dynamic risk factors for sexual recidivism. Medications in combination with psychotherapeutic techniques appear to produce better outcome in management of this risk factor. In this workshop, the presenters will discuss the physiology of male sexual arousal, the role of sex hormones and neurotransmitters, mechanisms by which medications reduce sexual preoccupation/hypersexual behaviors, cognitive behavioral techniques that are beneficial in decreasing hypersexual behaviors, and optimal integration of cognitive behavioral therapy and medications for best treatment outcomes.

### **10. The Impact of Telling True Stories**

*Luke Malone, MA, Journalist*

This workshop is based on Luke's work for the past two years with Dr. Elizabeth Letourneau interviewing the families and central players of four crimes that came to dictate sexual offender laws in this country: the rape of Ryan Hade; the disappearance of Jacob Wetterling; the rape and murder of Megan Kanka; and the murder of Adam Walsh. Together, these crimes led to the implementation of sex offender civil commitment, the sex offender registry, and community notification. Luke and Dr. Letourneau look at the impact of these policies and make the argument that we need to expand the current system to focus on prevention, in addition to prosecuting offenders and treating survivors. In this workshop, Luke will explain what their reporting has unearthed, including audio clips from some of the interviews they have recorded. He will also discuss the ways in which we can create an expanded public health focus on child sexual abuse prevention. Psychosexual evaluations are requested in a variety of settings, and at varying points in the criminal justice process. While keeping in line with the Risk-Need-Responsivity model, such evaluations are necessary in order to provide a comprehensive formulation of an individual's risk for re-offense, treatment needs, and responsivity factors; the ultimate goal being the appropriate allocation of resources for risk prevention. This presentation will provide a basic foundation for conducting psychosexual evaluations with adult male offenders by outlining important considerations for the process, relevant domains of evaluation, psychological and actuarial measures often utilized, and a discussion of case examples.

Clinical experience and research continue to refine and add to our understanding of psychopathic behavior. Myths and misunderstandings about the condition are corrected and more effective assessments and treatments are developed. This program reviews the development of our understanding and emphasizes new and emerging information on diagnostic tools, neurological aspects, treatments, and ethical issues.

## 17. Ethical Decision Making: Beyond Codes, Rules, and Laws (This is available only to those who attend the live workshop. It will not be recorded.)

When faced with an ethical dilemma, many therapists, if not most, respond reflexively out of fears of disciplinary actions by respective licensing boards or litigious actions by clients. This is probably more likely with therapists who work with sex offenders, forensic populations or clients with certain disorders, given these clients' propensity to make complaints or take legal actions. Ironically, reflexive decision-making processes can actually increase the likelihood of what therapist fear actually happening. This workshop will focus primarily upon developing an ethical decision-making process that takes into account multiple factors beyond considerations of board rules and legal concerns. Incorporating this process into practice, therapists are often able to respond in ways that serve to resolve ethical dilemmas effectively with less risk and greater likelihood of maintaining a positive therapeutic relationship with the respective client.

## 18. The Importance of a Flexible, Individualized, and Developmental Approach to the Evaluation and Treatment of Adolescents

There is reason to believe that people who commit sex offenses only as young people are a different profile than adults who commit sexual offenses. This training focuses on the importance of assessment and treatment that offers an individualized holistic approach to understanding adolescent sexual offending and draws upon an understanding of normal adolescent development rather than borrowing from the adult models. It challenges the reliance on over-manualized "one-size fits all" approaches and encourages an individualized approach that offers flexibility in modality, duration, intensity, and content.

### 21. Hitting Reset: Examining the Gamer Culture through a Sexual Offense Lens

It is estimated there are nearly 2.7 million gamers worldwide – some of those gamers are also individuals who commit sexual offenses. Sexual innuendo, online sexual interactions, and direct conversations about sexuality between adults and children is common in the gaming world. Understanding “gamer culture” and how gaming may be involved in both grooming behavior and committing sexual offenses is critical for treatment providers and probation. This workshop will use lecture and demonstration to illustrate the risks that gaming may pose when sexual offense behavior is involved. The use of gaming consoles to browse the Internet for pornography and store illegal images will be discussed. Further, Internet Gaming Addiction is a current diagnosis being considered for inclusion in the next edition of the Diagnostic and Statistical Manual (DSM) – this diagnosis will be discussed in terms of its possible overlap with sexual offense behavior. Prevention strategies for protecting children and the positive aspects of individuals who have committed a sexual offense using online gaming will be included.
